1. DOMESTIC ORDERS

1.1 DEPOSIT

A deposit of 50% of the full purchase price must be lodged with order in Australian funds. Our banking details are as follows :

1.2 PAYMENTS AND CONDITIONS

Payment of the remaining 50% of purchase price is required prior to shipment of goods. Title for the goods does not pass to customer until full payment for the goods has been received.

1.3 SALES TAX

The quoted price does not include sales tax, which is payable by the purchaser if applicable.

2. INTERNATIONAL ORDERS

2.1 DEPOSIT

A deposit of 50% of full purchase price must be lodged with order in Australian funds. Our account details are as follows :

2.2 METHOD OF PAYMENT OF BALANCE OF PURCHASE PRICE

Payment of the balance of purchase price must be by confirmed, irrevocable L/C payable at sight, for 50% invoiced C.I.F. value, in favour of **Autoscan Systems Pty. Ltd., 4/293 Bay Street, Brighton VIC 3186 (Postal address : PO Box 112, Ormond VIC 3204), Australia**, payable at **HSBC Bank Australia Ltd.** in Australian Dollar funds. HSBC Melbourne office is at : 99 William Street, Melbourne, Vic 3000 (Postal address : PO Box 763G, Melbourne, Vic 3001). Tel. + 613 9618 3888, Fax : + 613 9618 3777. SWIFT Address – hkbau2s

An alternative is offered of paying 100% on shipment by Letter of Credit, but is subject to a 10% surcharge to cover cost of funds. See also item 2.4 for L/C clauses.

2.3 CUSTOMS CLEARANCE

Customs clearance on arrival is to be arranged by the purchaser. Any local custom charges or taxes are to the purchaser's account.

2.4 CONDITIONS OF THE L/C

In the event of purchase on an FOB basis, the L/C is to include the following conditions :

- All bank charges outside Australia for account of applicant
- Latest shipping date : 210 days from date of opening of L/C
- AWB consignee must be applicant's issuing bank
- L/C expiry date : 15 days after last shipping date
- In the event of purchase on a CIF basis, the L/C is also to include the following conditions :
- Trans-shipment allowed
- Carriers other than local carriers are allowed

The L/C must be opened within 30 days of lodgement of order and deposit.

3. SHIPMENT

Shipment is estimated to be within 180 days of receipt of order and deposit. Consignment is to nearest customs-clearing airport via standard air freight.

4. VALIDITY

All prices quoted are firm for 30 days from the date of this proforma and are thereafter subject to variation. Prices will remain firm if order is received within 30 days.

5. LIMITED WARRANTY

AUTOSCAN SYSTEMS PTY. LTD. will repair or replace, at its discretion, defective special purpose components (stage, joystick, electronics) free of charges, provided that the customer bears the cost of freight to and from AUTOSCAN SYSTEMS PTY. LTD. and that our inspection shows the defect to be due to material or production fault. This warranty is valid for 12 months from the original shipment date of the equipment. Manufacturer's warranty (typically 90 days) applies to bought-in components.

6. LIMITATION OF REMEDIES

In no event will AUTOSCAN SYSTEMS PTY. LTD. be liable for any damages, including incidental or consequential damages arising out of the use or inability to use our equipment, even if AUTOSCAN SYSTEMS PTY. LTD. has been advised of the possibility of such damages, or for any claim by any other party.
